- a. **Action Item 1:** Review community generated letter requesting improvement of pedestrian safety at intersection of Madison Ave and Louisiana Street, and recommend to the full NPPC board to endorse/not endorse this proposal.

Summary: Based on safety concerns of inadequate traffic controls at the intersection of Madison Ave and Louisiana Street, community members are requesting that the city expedite the installation of a marked crosswalk with Rectangular Rapid Flash Beacons (RRFB). The community also invites a study of additional traffic calming measures such as stop signs or curb extensions to reduce vehicle speeds and improve safety for all.

The letter presented to this committee included 21 signatures by community members who reside near this subject intersection.

b. **Information Item 1: Status of University Avenue Mobility Project**

Project Background: The University Avenue Mobility Project, extending from Florida Street to Boundary Street, focuses on improving safety and mobility along the corridor for pedestrians, bicyclists, transit and automobile traffic.

According to the City of San Diego's website on this project, [University Avenue Mobility Project | City of San Diego Official Website](#), the project is anticipated to be completed in early 2025. Remaining work according to the website includes the following (specific dates to be determined):

- Finalize signal at University Avenue and Ohio Street.
- Complete flatwork restoration at Ohio Street, Grim Avenue, and Illinois Street.
- Complete remaining asphalt overlay and striping work.

Community members have expressed frustrations with the extended timeline to complete this project and have cited both inconveniences and safety hazards due to the incomplete status of this project. The purpose of this agenda item is to both document community concerns as well as seek updates from the city on completion expectations.
