NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

LOCATION: The project is located at 13500 Camino Del Sur, San Diego, CA 92129

PROJECT DESCRIPTION: Neighborhood Use Permit (NUP) to allow the removal of an existing temporary Wireless Communication Facility (WCF) and the construction of a new permanent WCF on residential building rooftop. The scope of work includes new FRP screens, (6) antennas on the rooftop, (6) RRUS and associated WCF ancillary equipment. The project is located at 3560 Mount Acadia Blvd. in the Clairemont Mesa Community Plan Area, Clairemont Mesa Height Overlay Zone, Base Zone CN-1-2, FAA-Montgomery Field, Council District 2. The WCF is unmanned and is not for human habitation and there will only be monthly maintenance trips to the project site.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review which determined that the proposed project is exempt from CEQA pursuant to CEQA Guidelines Section 15302. CEQA Section 15302 allows for the replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site and will have substantially the same purpose and capacity as the structure being replaced. The proposed project is modifying an existing WCF and would replace the old facility with a new one. No environmental impacts were identified for the proposed project and none of the exceptions described in CEQA Guidelines Section 15300.2 apply.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal. Please include the project number on the memo line of the check.

Bring the fully completed appeal application [DS-3031](#) (including grounds for appeal and supporting documentation) to the City Administration Building—Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City-approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period.
