#### **ITEM 1: 375 CAMINO DE LA REINA – PROJECT NO. 1116361**

**Plan Area:** Mission Valley

Conditional Use Permit request to allow a new Alcoholic Beverage Outlet located in ground level Suite B of an existing mixed-use building at 375 Camino De La Reina. The 4.88-acre site is in the RMX-1 zone within the ALUCP Airport Influence Area (Montgomery Field and San Diego International Airport – Review Area 2) and the Mission Valley Community Plan.

This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301 (Existing Facilities). [Report No. HO-25-003](#).

#### **ITEM 2: ROMERO DRIVE SINGLE DWELLING UNIT – PROJECT NO. 1112271**

Coastal Development Permit and Variance to construct a 4,792-square-foot, two-story single dwelling unit over a partial basement with a 462-square-foot attached garage. The vacant 0.41-acre lot is located at the southwest end of Romero Drive, (also known as Assessor's Parcel Number 352-261-04-00) in the RS-1-4 zone (Residential-Single Unit), the Coastal Overlay Zone (Non Appealable Area), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, and the Very High Fire Hazard Severity Zone with the La Jolla Community Plan and Local Coastal Program.

This project was determined to be categorically exempt pursuant to Section 15303 (New Construction) of the California Environmental Quality Act. [Report No. HO-25-004](#).

**ITEM 3: 741 SUNSET CLIFFS BOULEVARD – PROJECT NO. 1105619**

**Plan Area:** Peninsula

Coastal Development Permit to construct a two-story, 2,339-square-foot single dwelling unit with a detached 960-square-foot garage. The 0.25-acre vacant site is located at 741 Sunset Cliffs Boulevard in the RS-1-7 zone (Residential-Single Unit), the Coastal Overlay Zone (Appealable Area), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, the Airport Land Use Compatibility Overlay Zone, and the Airport Influence Area (San Diego International Airport and Naval Air Station North Island Review Area 2) within the Peninsula Community Plan area.

This project was determined to be categorically exempt pursuant to Section 15303 (New Construction or Conversion of Small Structures) of the California Environmental Quality Act. [Report No. HO-25-008](#).

**HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:**

**In Person for Agenda Items and Non-Agenda Public Comment:** Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

**Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:** When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

**Late-Arriving Materials:**

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3<sup>rd</sup> Floor, San Diego, CA. 92101.
