#### FOUNDATION REPORT - Lane MacKenzie

- By the end of this month the Foundation will be closing on a third parcel, with a total of 105 acres across five parcels acquired since April
- The second cohort of the Eco Ambassadors program starts this Sunday from high schools all over the county
- The Foundation welcomed over 3000 students on field trips last year and the field trip program will start up again in a few weeks
- This weekend we are hosting a New York Times bestselling author for two sold out presentations about the importance of creating habitat in our communities

**302.** Bridge For Max Project Update – Evan Lakin KPFF, Kevin Legge

- In comment exchange phase with the City of San Diego
- Bridge height, location, has been approved
- Flatiron construction has been selected as contractor
- Environmental mitigation measures have been outlined with all of it occurring within MTRP
- Goal is to mobilize September 2025 and complete by February 2026

**303.** East County Advanced Water Purification Project Update – *Rebecca Abbott, Engineering Manager, East County Advanced Water Purification Joint Power Authority* 

- CEQA addendum is complete, project now has all approvals necessary for construction
- JPA board of directors project approvals are complete
- City of San Diego approval on the JPA city cost sharing agreement is in process
- The agreement has passed at the environmental committee
- The agreement has passed at the first city council reading in December
  - Second city council reading is next week
- The 100 percent design plans are being reviewed
- The City's engineering team which is the Strategic Capital Projects Department, will be sharing the plans with Parks and Recreation staff shortly
- Notice to proceed with construction is anticipated by March 1<sup>st</sup>
- Proposed schedule:
  - Clearing, grubbing, to occur late February March
  - o Install wet weather bypass pipeline install estimated May-July 2025
  - Drain the force main July 2025
  - Sliplining construction July 2025 end of 2027

**304.** Old Mission Dam Dredging Project Update – Rob Wheeler, Senior Park Ranger, MTRP

Dredging project is complete

**305.** Oak Grove Loop Trail Resurfacing Project Update – *Ed Christensen, Supervising Park Ranger, Open Space Division* 

- Met with in-house Open Space support crew to discuss an in-house approach to completing the project
- Additional \$100k attached to the project has spending criteria limitations
- Meeting set up tomorrow to get more clarification on available funds
