## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

PROJECT NAME: Special Event Permit - ANN

**COMMUNITY PLAN AREA:** Downtown

**COUNCIL DISTRICT:** 3

**LOCATION:** 5th Avenue between L and J Street

**PROJECT DESCRIPTION:** Special Event Permit for a private corporate block party, 21 and over, event that would include the temporary use of a stage, seating, entertainment, games, bar, food preparation, food stations, pizza truck, surf simulator, alcohol, tents/canopies, lighting, décor, generator, fencing and/or barriers, portable restrooms, recycle/trash containers, tables, and chairs, to occur in Downtown area within 5th Avenue between L and J Street, and production would occur on K Street between 4th and 6th Avenue, and J Street between 4<sup>th</sup> and 6<sup>th</sup> Avenues, on April 6, 2025. Noise associated with the event activities and set-up/dismantling would occur from 6 AM on April 6, 2025, until 6 AM on April 7, 2025. A stage would be used for entertainment, and sound amplification would occur from 5 PM until 10:30 PM. On April 6, 2025, set-up would occur from 6 AM until 7 PM, and the event would occur from 7 PM until 10:30 PM. Dismantling would occur from 10:30 PM on April 6, 2025, until 6 AM on April 7, 2025. Approximately 4,000 attendees are anticipated throughout the course of the event.

Road and street parking closures would be associated with the event and would occur from 6 AM on April 6, 2025, until 6 AM on April 7, 2025, and would include 5th Avenue between L Street to J Street, J Street between 4<sup>th</sup> and 6<sup>th</sup> Avenue, and K Street between 4<sup>th</sup> and 6<sup>th</sup> Avenue.

Additional street parking closures include 4<sup>th</sup> Avenue between J and K Streets, and J Street between 4<sup>th</sup> and 6<sup>th</sup> Avenues.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for

causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
