## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Alvarado Laboratory Improvements

COMMUNITY PLAN AREA: Navajo

**COUNCIL DISTRICT:** 7

**LOCATION:** The project is within the Alvarado Water Treatment Plant located at 5540 Kiowa Drive, San Diego, CA 91949.

**PROJECT DESCRIPTION:** The project will remodel an approximately 43,400-square-foot existing laboratory facility, construct an approximately 31,400-square-foot two-story addition to the laboratory building, construct approximately 18,000 square feet of underground parking, improve an existing adjacent surface parking lot, and install a photovoltaic solar array system. The project will also rehabilitate an existing 72-inch diameter pressurized water pipe underneath the laboratory building and install a new drainage system.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** This activity is categorically exempt from CEQA pursuant to CEQA State Guidelines, Section 15301 (Existing Facilities), and Section 15332 (Infill Development).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Engineering & Capital Projects Department

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review which determined that the project meets the categorical exemption criteria set forth in CEQA State Guidelines, Section 15301 (Existing Facilities), which allows for the minor alteration of existing public structures, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination, such as remodeling and improvements to existing laboratory facilities, improvements to the existing parking lot and rehabilitation of an existing pressurized water pipe; Section 15332 (Infill Development), which allows for in-fill development that is consistent with the applicable general plan, occurs within city limits on a site no more than five acres, occurs on a site that has no value as habitat for endangered, rare, or threatened species, would not result in any significant effects relating to traffic, noise, air quality, or water quality, and would be adequately served by all required utilities and public services, such as construction of a new two-story laboratory building addition, underground parking, and photovoltaic system; and where the exceptions listed in Section 15300.2 would not apply.

The appeal filing fee must be United States Postal Service (USPS) postmarked within five (5) business days of the date the appeal is filed.
