# <u>PUBLIC FORUM - NON-AGENDA ITEMS (THREE MINUTES PER SPEAKER SIX MINUTES PER TOPIC)</u>

PeggyWalker is a public health policy advocate working with San DIegito Alliance and Terry-Ann Skelly who is unavailable this evening. She recently attended a sheriffs meeting regarding the flood of sales of THC related products which are considered dangerous as well as a substance and a schedule one narcotic derived from mushrooms, all of which are readily available and consistently mislabeled. As part of the meeting data was presented on the increased number of E/R admissions related to these substances. All community members should be on alert.

## PUBLIC OFFICIALS (INFORMATION AND ANNOUNCEMENTS)

#### MAYOR TODD GLORIA'S OFFICE - Fatima Maciel

Fatima introduced herself as the District 1 rep from the Mayors office. Of interest she noted that the next 90 days if a car is parked within 20 feet of a cross walk a warning will be issued, after that tickets will be issued. She also raised the concern for rainy season especially flood zones and is preparing information and notices on flood preparedness as well as fire preparedness. San Diego has deployed two fire engines to the LA area to assist with the current disaster. There are vacancies on city boards and commissions and is available to provide any information for interested parties. Chairman Metcalf requested of Fatima to find out how to determine the "recommended" plan for evacuation being either Del Mar Mesa Road or Carmel Mountain Road. Fatima commented that this is very much determined by the location of the fire as well as the direction of the wind. San Diego Fire Rescue and the Police Department work together to determine the best direction of evacuation. Fatima suggested that DMM establish a Community Fire Council and will provide support in how to set one up.

## COUNCIL DISTRICT 1 - COUNCIL MEMBER JOE LACAVA: JOAQUIN QUINTERO

Joaquin Quintero raised the availably of resource material on the fire preparedness and planning. Council member Jo Lacava as been elected as San Diego Council President. The five year outlook reflects a \$258M shortfall, and there will be difficult decisions to be made. He also reported that he has no update on the surveillance camera program. On the matter of the Del Mar Mesa road safety issues, no results are available yet. He will follow up to see if there can be available information and traffic study results for the February meeting. Nicole Smith commented on a past study that has been approved which Joaquin agreed has been approved but not completed. Nicole also asked about the potential of multiple solutions. Chairman Metcalf

noted that certain steps must be completed first to support the process of the implementation of resulting changes, which will be impacted by the budget deficit. Chairman Metcalf made reference to an email he sent out last month regarding this matter.

He will relay to the assembly person that the matter of fire insurance is a significant matter to Del Mar Mesa. Derek Reeves asked about the responsible party for brush management of the sewer road. Wendy reported that the HOA is responsible only until the black fence and agreed that the brush is very dense. Barry Cohen commented that there had been work done by the city a while back but the density of the underbrush beyond the trails and sewer road is very dense. Chairman Metcalf commented that this is due to the MSCP which keeps hands off as protected area.
