ITEM 1: ANYTIME FITNESS UPTOWN – PROJECT NO. 1114608

Staff: Travis Cleveland City Council District: 3 Plan Area: Uptown

Conditional Use Permit for 24-hour operation of an existing Anytime Fitness located at 335-365 W. Washington Street. The 0.44-acre site is in the CC-3-10 zone within the Airport Land Use Compatibility Overlay Zone for NAS North Island (NASNI) and San Diego International Airport (SDIA), the Airport Influence Area (NASNI and SDIA), the FAA Part 77 Noticing Area (NASNI and SDIA), the Community Plan Implementation Overlay Zone (CPIOZ-A), the Transit Area Overlay Zone, a Parking Standards Transit Priority Area, and a Transit Priority Area within the Uptown Community Plan.

This project is within the scope of the Vons Mission Hills Mitigated Negative Declaration (Project No. 201016) adopted on December 7, 2010, via Resolution No. R-306488. This Mitigated Negative Declaration adequately describes the activity for the purposes of the California Environmental Quality Act (CEQA). <u>Report No. HO-25-010</u>.

ITEM 2: 7356 RUE MICHAEL – PROJECT NO. 1065911

Staff: Robin MacCartee City Council District: 1 Plan Area: La Jolla

Site Development Permit, Coastal Development Permit, and Public Service Easement Vacation to demolish an existing single dwelling unit with attached garage and construct a new 15,433-square-foot (sf) single dwelling unit, 1,200-sf Accessory Dwelling Unit (ADU), a 2,779-sf attached garage, and a new pool and spa. The project also proposes to vacate an unused sewer easement. The 0.30-acre project site is located at 7356 Rue Michael in the La Jolla Shores Planned District-Single Family (LJSPD-SF) zone, the Coastal Overlay Zone (Non-Appealable Area), the Coastal Height Limit Overlay Zone, and the Parking Impact Overlay Zone within the La Jolla Community Plan. The project was determined to be categorically exempt pursuant to Section 15332 (In-fill development) of the California Environmental Quality Act. <u>Report No. HO-25-007</u>.

DEPARTMENT RECOMMENDATION

Staff: Hector Rios **City Council District:** 1 **Plan Area**: University

Coastal Development Permit and Site Development Permit to demolish an existing 76,694-square-foot research and development building and construct a new 152,080square-foot research and development building, 44 surface parking spaces, and a fourlevel subterranean parking garage with approximately 440 parking spaces. The 10.2-acre site is located at 11011 Torreyana Road in the IP-1-1 zone, the Airport Land Use Compatibility Overlay Zone (MCAS Miramar), the Airport Influence Area (MCAS Miramar-Review Area 1), the Airport Safety Zone (MCAS Miramar, Accident Potential Zone 2), the Coastal Height Limit Overlay Zone, the Coastal Overlay Zone (Non-Appealable Area 1), the Community Plan Implementation Overlay Zone (CPIOZ-B), a Transit Priority Area, the Multiple Habitat Planning Area (MHPA), a Very High Fire Severity Zone, the Parking Impact Overlay Zone, the First Public Roadway, and Prime Industrial Lands within the University Community Plan.

<u>Subsequent Mitigated Negative Declaration No. PRJ-1058759/SCH No. 2019060003</u> was prepared in accordance with the California Environmental Quality Act Statute and Guidelines. <u>Report No. HO-25-013</u>.

DEPARTMENT RECOMMENDATION Approve the project.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3rd Floor, San Diego, CA. 92101.
