ITEM 1: 7356 RUE MICHAEL - PROJECT NO. 1065911

Staff: Robin MacCartee City Council District: 1 Plan Area: La Jolla

Site Development Permit, Coastal Development Permit, and Public Service Easement Vacation to demolish an existing single dwelling unit with attached garage and construct a new two story, single dwelling unit, with a 3,740-sf main level, a 2,860 sf second level, a 2,919-sf basement, a 2,779-sf attached subterranean garage, and a 1,200-sf attached subterranean ADU. The project also proposes to vacate an unused sewer easement. The 0.30-acre project site is located at 7356 Rue Michael in the La Jolla Shores Planned District-Single Family (LJSPD-SF) zone, the Coastal Overlay Zone (Non-Appealable Area), the Coastal Height Limit Overlay Zone, and the Parking Impact Overlay Zone within the La Jolla Community Plan.

The project was determined to be categorically exempt pursuant to Section 15332 (In-fill development) of the California Environmental Quality Act. <u>Report No. HO-25-007</u>.

DEPARTMENT RECOMMENDATION

Approve the project.

ITEM 2: *1821 VIKING WAY – PROJECT NO. 1114539

Staff: Karen Bucey City Council District: 1 Plan Area: La Jolla

Site Development Permit for an addition and remodel at an existing one-story, 2,694square-foot single dwelling unit with an attached garage. Additions total 851 square feet. The 0.18-acre site is located at 1821 Viking Way in the La Jolla Shores Planned District Single-Family (LJSPD-SF) zone, the Coastal Overlay Zone (Non-Appealable Area), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, the Transit Area, a Parking Standards Transit Priority Area, and the La Jolla Shores Archaeological Study Area within the La Jolla Community Plan and Local Coastal Program Land Use Plan. Mitigated Negative Declaration No. 1114539. Report No. HO-25-011.

DEPARTMENT RECOMMENDATION

Approve the project.

ITEM 3: 630 SAN ANTONIO – PROJECT NO. 1110305

Staff: Karen Bucey City Council District: 2 Plan Area: Peninsula

Coastal Development Permit to demolish an existing 2,048-square-foot, two-story single dwelling unit and build a new 4,117-square-foot, two-story single dwelling unit with attached garage, landscape, hardscape, and spa. The 0.14-acre site is located at 630 San Antonio Avenue in the RS-1-7 (Residential Single Dwelling Unit) zone, the Coastal Overlay Zone (Appealable Area), the Coastal Height Limit Overlay Zone, and the First Public Roadway within the Peninsula Community Plan and Local Coastal Program Land Use Plan.

This project was determined to be categorically exempt pursuant to Sections 15301 (Existing Facilities) and 15303(a) (New Construction or Conversion of Small Structures) of the California Environmental Quality Act. <u>Report No. HO-25-012</u>.

DEPARTMENT RECOMMENDATION

Approve the project.

ITEM 4: MARGARITAVILLE LIVE ENTERTAINMENT – PROJECT NO. 1115941

Staff: Johnwilly Aglupos City Council District: 3 Plan Area: Downtown

Conditional Use Permit to allow indoor and outdoor live entertainment at the Margaritaville Hotel. The 35,109-square-foot site is located at 435 Sixth Avenue at the northeast corner of Sixth Avenue and J Street within the Ballpark Mixed-Use land use district of the Centre City Planned District, a Transit Priority Area, and the East Village neighborhood of the Downtown Community Plan.

The Project is consistent with the previously certified <u>Downtown Final</u> <u>Environmental Impact Report</u> as amended and no additional environmental document is required under the California Environmental Quality Act. <u>Report No. HO-25-009</u>.

DEPARTMENT RECOMMENDATION

Approve the project.

HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the <u>webform</u>, indicating the comment type and item number (if relevant). Comments must be the business day prior for it to be distributed to Hearing Officer. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer <u>website</u> for further instructions.

Written Materials: Instead of submitting materials as an attachment to the <u>webform</u>, you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3rd Floor, San Diego, CA. 92101. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.

Please note: Approximately one hour prior to the start of the Hearing Officer meeting, the documents will be available just outside the meeting location as identified herein in a binder labeled "Late-Arriving Materials". Late arriving materials received during the Hearing Officer meeting are available for review by making a verbal request of the Legislative staff at the meeting location.
