Subj: The Necessity of Design Review and Assistance

Dear Committee Members,

This matter is especially timely as the Balboa Park Committee recently discussed the Design Review proposals from the consulting firm AEA in their Prioritization Framework report. The recommendations in the AEA report parallel and complement the suggestions and recommendations in the Design Review Exploratory Committee report. [Attached].

The Balboa Park Committee of 100 provided a comprehensive assessment of the background and purposes of Design Review/Assistance in their letter dated February 1, 2025, which said in part:

"The Exploratory Committee (EC) was chaired by Mike Stepner, former City Architect, and included former members of the Balboa Park Committee (BPC), Connie Matsui of Forever Balboa Park, and René Smith of the Committee of 100. The Committee was formed based on discussions about the Sixth Avenue toilets at the August 2019 BPC meeting. The BPC said there needed to be a review of how they looked at projects in the park. The EC also included representatives of park interest groups, design consultants who have worked in the park, former Design Review committee members, and staff from the Parks and Recreation Department.

The EC's recommendations include forming a Balboa Park Committee standing design review and assistance subcommittee. This Subcommittee could be modeled after a similar standing committee of the Historic Resources Commission. Also included is a process for early review of park projects. The Committee of 100 believes that design review and assistance offers one of the

most effective ways of constructively managing community feedback about projects connected to Balboa Park, facilitating a path to consensus."

Further, it commented: "In the interest of thoughtful growth, the Committee of 100 advocates renewing a long-standing commitment to collaboration and cooperation through Design Review Assistance for all major projects planned for the park by the creation of a standing subcommittee of the Balboa Park Committee of the City of San Diego."

The Committee of 100 believes, as a thoughtful and engaged community devoted to Balboa Park's future, that we can do better together."

The Design Review Exploratory Committee and the AEA report proposed a standing committee formed by the City of San Diego Parks and Recreation Board subcommittee.

We support the Parks and Recreation Director's recommendation for changes to the municipal code to create a standing committee modeled after the Historic Resources Board Design Assistance subcommittee.

I recommend the immediate creation of a one-year Balboa Park Committee Ad Hoc Committee on Design Assistance. It could be constituted of three members of this Committee. In addition to Design Assistance, the Subcommittee could provide formal recommendations to the Balboa Park Committee at the end of the one year regarding permanently institutionalizing Design Assistance. Such action supports the Design Review/Assistance action in the Parks Master Plan, which calls for the study of the feasibility of Design Review.

There is no other "Crown Jewel" in the City.
