ITEM 1: 376 SILVER GATE AVENUE – PROJECT NO. 1111391

Plan Area: Peninsula

Coastal Development Permit to remodel an existing one-story 2,510-square-foot single-dwelling unit, convert a portion of an existing 668-square-foot garage into a 472-square-foot Accessory Dwelling Unit and add the remaining 196 square feet to the primary dwelling unit as an additional bedroom, construct a new 513-square-foot two-car garage, and add a 292-square-foot family room at 376 Silver Gate Avenue. The 0.24-acre site is in the RS-1-4 (Residential Single-Dwelling Unit) zone, the Coastal Overlay Zone (Appealable Area), the Coastal Height Limit Overlay Zone, and the First Public Roadway within the Peninsula Community Plan area. This development is within the Coastal Overlay zone.

This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA State Guidelines, Section 15332, In-Fill Development Projects. [Report No. HO-25-017](#).

ITEM 2: *11011 TORREYANA ROAD – PROJECT NO. 1058759

Plan Area: University

Coastal Development Permit and Site Development Permit to demolish an existing 76,694-square-foot research and development building and construct a new 152,080-square-foot research and development building and a four-level subterranean parking garage with approximately 440 parking spaces and 44 surface parking spaces. The 10.2-acre site is located at 11011 Torreyana Road in the IP-1-1 zone, the Airport Land Use Compatibility Overlay Zone (MCAS Miramar), the Airport Influence Area (MCAS Miramar-Review Area 1), an Airport Safety Zone (MCAS Miramar Accident Potential Zone 2), the Coastal Height Limitation Overlay Zone, the Coastal Overlay Zone (Appealable), the Community Plan Implementation Overlay Zone - Type B (CPIOZ-B), a Transit Priority Area

(TPA), the Multiple Habitat Planning Area (MHPA), a Very High Fire Severity Zone, the Parking Impact Overlay Zone, Coastal Overlay Zone First Public Roadway (COZFPR), and Prime Industrial Lands within the University Community Plan.

You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. Late-Arriving Materials:
