**PROJECT DESCRIPTION:** This action is for approval of an environmental consultant services contract with Dudek to provide an expanded facility investigation and assessment, which includes subsurface soil sampling. The soil samples will be taken both within and immediately outside the police facility.

On April 9<sup>th</sup>, 2025 the City of San Diego made the above-referenced environmental determination pursuant to the California Environmental Quality Act (CEQA). Applications to appeal CEQA determinations made by staff to the City Council must be filed in the Office of the City Clerk within five (5) business days from the date of the posting of this Notice April 16<sup>th</sup>, 2025. Appeals to the City Clerk must be filed by email or in-person as follows:

The appeal filing fee must be United States Postal Service (USPS) postmarked within 5 business days of the date the appeal is filed.
