### ITEM 1: POWELL RESIDENCE

**Staff:** Benjamin Hafertepe **City Council District:** 2 **Plan Area:** Clairemont Mesa

Site Development Permit and Tentative Map to subdivide Parcel 1 of Parcel Map No. 21729 located at 2343 Garfield Road into two parcels. Parcel 1 will be 0.19 acres (8,540 square feet) and will include the existing one-story single dwelling unit with an attached garage fronting Garfield Road, and Parcel 2 fronting Kane Street will be 0.27 acres (11,925 square feet). The project also proposes the construction of a new three-story single dwelling unit with an attached garage and attached accessory dwelling unit totaling approximately 3,815 square feet on Parcel 2. The 0.46-acre site is in the RS-1-7 zone, the Airport Land Use Compatibility Overlay Zone (San Diego International Airport and Montgomery Field), the Clairemont Mesa Height Limit Overlay Zone, the Airport Influence Area (Montgomery Field – Review Area 2 and San Diego International Airport – Review Area 2), the Federal Aviation Administration Part 77 Noticing Area, and a Very High Fire Hazard Severity Zone within the Clairemont Mesa Community Plan.

This project was determined to be categorically exempt pursuant to Section 15303 (New Construction). <u>Report No. PC-25-008</u> <u>Attachment 1-10</u> <u>Attachment 11-12</u>

#### ITEM 2: \*VISTA SANTO DOMINGO REZONE AND CPA

Staff: Sara Osborn City Council District: 8 Plan Area: Otay Mesa

A General Plan Amendment and Community Plan Amendment to change the land use designation from Residential-Medium to Light Industrial, a Rezone from RM-2-4 (Residential Medium) to IL-1-1 (Industrial-Light) and a San Diego Municipal Code Amendment to Chapter 13, Article 2, Division 14 - Community Plan Implementation Overlay Zone (CPIOZ) boundary for the Otay Mesa Community Plan to include the project site in the CPIOZ – Type A boundary. No development is being proposed as part of this project. The vacant 5.58-acre site is located northeast of the terminus Vista Santo Domingo and Exposition Way and north and west of Innovative Drive (Assessor's Parcel Number: 645-050-4400). The site is partially within the CPIOZ -Type A, and within the Very High Fire Hazard Severity Zone, the Airport Land Use Compatibility Overlay Zone (Brown Field Municipal Airport), the Airport Influence Area (Review Area 1), Airport Safety Zones 2 and 3, and the Federal Aviation Administration Part 77 Notification Area within the Otay Mesa Community Plan.
