- a. **Action Item 1 (6:15-6:35):** The Uptown Community Planning Group (UpCPG) reached out to NPPC to collaborate on recommendations for the intersection at El Cajon Boulevard, Normal Street, and Park Boulevard, which is shared by both of our planning groups. With the continuing development and increased vehicle, pedestrian, and bicycle traffic in this area, UpCPG is requesting for the city to take action to study and reconfigure this intersection to make it safer for all users. The PF&T subcommittee will review and edit the UpCPG proposed letter, and vote on a recommendation for the full NPPC board to submit the letter to the city. Besides any possible content changes to the letter, other considerations are whether to submit the letter jointly by both planning groups, or individually, and whether to encourage community members to individually submit [Traffic Service Request | City of San Diego Official Website](#) for this intersection.
