NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit- 14th Annual Doggie Street Festival & Adopt-A-Thon

COMMUNITY PLAN AREA: Peninsula

COUNCIL DISTRICT: 2 **LOCATION:** NTC Park

PROJECT DESCRIPTION: Special Event Permit for a pet adoption event within NTC on November 18, 2023. The event would include the dog, cats, animal adoptions, onsite food preparation, the temporary use of tables, chairs, canopies, and entertainment/performances, sound amplification, portable restrooms, trash/recycling containers. Noise associated with the event activities and set-up/dismantling would occur from 7 AM on November 17, 2023, until 5 PM November 18, 2023. Set-up would occur from 7 AM until 4 PM on November 17, 2023, and from 7 AM until 9 AM on November 18, 2023. The event would occur from 9 AM until 3 PM, and dismantling would occur from 3 PM until 5 PM on November 18, 2023. The expected number of attendees would be approximately 1500.

No road closures would be associated with the event.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no

significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
