Please join us on **Thursday, February 9 at 6 pm** at the Grace Lutheran Church in University Heights for an interactive workshop to start developing our own community plan for the future of University Heights. The session will focus on preparing the community for the draft Uptown Community Plan, anticipated for release as early as summer of this year.

On February 9, Leo Wilson, Chair of Uptown Planners, and Kristin Harms, Chair of the UH Historical Society and member of the UH Community Development Corporation Board of Directors, will:

- Review highlights of the 2008 San Diego General Plan
- Describe elements of the draft Uptown Community Plan
- Present SANDAG population estimates for University Heights
- Review results of community brainstorming session on January 12
- Facilitate establishment of work groups to review General Plan Element goals and policies, and develop recommendations for UH

Our hope is to have enough participants for nine work groups to focus on each of the nine elements of the General Plan:

1) Land Use and Community Planning, 2) Mobility, 3) Economic Prosperity, 4) Public Facilities, Services, and Safety, 5) Urban Design, 6) Recreation, 7) Historic Preservation, 8) Conservation, and 9) Housing.

The workgroup process will undoubtedly take a couple of sessions to complete but we hope to at least establish our nine work groups on February 9 and then schedule follow-up sessions as needed.
