 - 1. **Lose the Roaditude**. This campaign is aimed at increasing the awareness of common rules and curbing aggressive behavior on the road between bicyclists, motorists and pedestrians.

- III. Information Items
 - A. Sewer Rehabilitation Phase J1-A, 100% Design Phase. Part of a program established by the City of San Diego and the Environmental Protection Agency mandating the rehabilitation of old and deteriorated concrete sewer mains. This project includes the rehabilitation of 33,621 linear feet (6.37 miles) of sewer main which would occur in the City's right-of-way utilizing trenchless technology. Access to rehabilitate the sewer mains will be through the existing manholes and/or cleanouts. Locations within the Greater North Park area are as shown in the attached map. Construction to begin in January 2010 with a six (6) month duration. (6:45 pm) Lotous Lenguyen, Laila Nasrawi.
 - B. **Sewer Main Replacement Group 644.** Replacement of approximately 5,698 linear feet (1.08 miles) of sewer main within the City's right-of-way of Palm Street, McKinley Street, alley Block H, Quince Street, Little Flower Street, Teresita Street, Felton Street, Nutmeg Street, Redwood Street, Commonwealth Street, Laurel Street, and Boundary Street in the Greater North Park area as shown in the attached map. Construction to begin in October 2010. (7:05 pm) Elizabeth Dunn, Jericho Gallardo.

 - **A.** Review of Permitting Process for Taxi Drivers. The permit process in other cities allows for the verification of insurance and conducing Department of Motor Vehicles and criminal background checks; taxis that pick up passengers in other cities have a permit with a photo on display along with a certificate by their County and a current rate table; taxi drivers in other cities picking up customers without a permit can face a misdemeanor conviction that carries a fine.
