Re: Abandon the SR-94 HOV Project

The City Heights Area Planning Committee formally requests that the city's representatives to SANDAG schedule an agenda item on the SR-94 HOV project so we can have an open discussion regarding whether this project is worthwhile and whether it should be pursued.

Dear Mayor Filner, ladies and gentlemen,

At its regular meeting earlier this month, the City Heights Area Planning Committee heard a presentation from Caltrans and SANDAG about high-occupancy vehicle lanes on SR-94 between roughly Interstate-805 and Interstate-5. The Committee held a lively, thoughtful discussion of the project and the \$500 millions (or more) that it will cost.

After discussion, the committee approved a motion urging Caltrans and SANDAG to abandon the project as it is now planned and spend the \$500 millions of TransNet funding on transportation and circulation improvements in the communities surrounding that section of SR-94 - Logan Heights, Memorial, Mount Hope, Mountain View, Sherman Heights, Grant Hill, Stockton and City Heights.

There seemed to be two themes in the CPG members' discussion:

- 1) as proposed, there is nothing of value for communities surrounding the section of SR-94 in question; and
- 2) it's obvious that SANDAG, acting through Caltrans, intends to make convenient motor vehicle transportation between affluent areas, like Chula Vista and the vicinity of MCAS Miramar, and downtown San Diego. The public recitation from Caltrans and SANDAG was of busses and mass transit for low- and moderate-income folks. In fact the plan speeds the daily commute of more affluent folks from the suburbs. The Committee seemed to see through the rhetoric and recognize the facts of the project. It took an appropriate action.

We understand that the Mayor and the President pro-tempore of the City Council are the City's appointees to the SANDAG Board. I urge them to arrange an agenda item at SANDAG soon to discuss this project with residents of the communities mentioned above, to decide how best to spend \$500-\$600 millions. We should have this discussion soon, before the project is hardened.

Dear Neighborhood Leaders,

Civic San Diego, on behalf of the City of San Diego, has prepared a Long-Range Property Management Plan (PMP) that addresses the non-housing real properties owned by the former Redevelopment Agency of the City of San Diego, now known as the "Successor Agency." This is plan is a requirement of State law under the Dissolution Act.

The PMP includes general recommendations for 44 sites scattered throughout eight of the City's former redevelopment project areas. In general, the PMP recommends that the City and Successor Agency retain ownership of the majority of the sites, many of which contain existing public facilities such as parks and parking structures, while others are sites purchased for redevelopment and public benefit purposes for which the City, Successor Agency and Civic San Diego hope to move forward to development in the future.

Starting tomorrow, July 17, 2013, the draft PMP will begin a public review process that will culminate in its review by the California Department of Finance in accordance with state legislation. The following meeting schedule includes the various public meetings and dates:
