# NPPC Board Elections will be held on March 19, 2013 **Voting Starts at 6:15 pm**

In accordance with NPPC bylaws & city policy voters must provide the following identification to vote: A current registration form on file and have signed in at one (1) NPPC meeting in the past year (from March 2011 to February 2012).

- Resident Homeowner or Renter: Registrant needs to produce a source of ID to establish their identity and residency in North Park. A driver's license with a current North Park current address is preferable. Failing that, a local utility bill (such as City Water, SDG&E, AT&T etc.) with an individual's name and address clearly stated.
- North Park Business Person: Business tax certificates will identify the owner or a partnership of owners on the certificate Registrant also needs to produce a source of ID to establish their identity a driver's license is preferable
- Designated North Park Business Representative: Will provide a letter from a business owner on business letterhead designating the individual as the business's representative. Will provide a copy of the business tax certificate that identifies the owner or partnership. Registrant also needs to produce a source of ID to establish their identity; a driver's license is preferable
- Non-Profit Entity or Umbrella Organization: Will provide a letter from the organization on organization's letterhead designating the individual as the business's representative, signed by a board member, administrator or manager Registrant will produce a source of ID to establish their identity; a driver's license is preferable
- Property Owner: A current property tax bill with voters name on it is preferable, but failing that, a local utility bill (such as City Water, SDG&E, AT&T etc.) or a copy of the page of your property owner's mortgage with the individual's name and property address clearly stated. Registrant will produce a source of ID to establish their identity; a driver's license is preferable
- Business &/or property owners who filled out a Registration Form & designated themselves as both a North Park business owner & resident owner/renter, for purposes of signing in to vote, are treated as a resident.

**Update from NPHS On Water Tower Historic Designation:** The Water Tower and associated historic buildings will be considered for placement on the National Register of Historic Places! The official meeting will be held on Wednesday, May 1, 2013 at 9:00 am at the Downtown Anaheim Community Center, A Hall, 250 East Center Street, in the City of Anaheim. The National Register is the United States' official list of historic properties worthy of preservation. Approval for the National Register automatically achieves listing in the California Register of Historical Resources as well. The agency that makes this decision is the State Historical Resources Commission. The State Historic Preservation Officer (SHPO) coordinates the process. Local historian Alex Bevil prepared the detailed application as a completely volunteer effort on behalf of the North Park Historical Society and University Heights Historical Society. The Water Tower and accompanying water system structures (some of which no longer exist) have been nominated as the "University Heights Water Storage and Pumping Station Historic District."

We hope many of you support this prestigious designation of our unique and highly visible landmark. You may write a letter for the Commission to consider when they make their decision. Send your letter before April 15 to:
