Petitions were mailed to Residents of the 551 properties on both sides of the affected blocks. After a 30-day input period, the City of San Diego received a total of 23 objection letters.



Note:

- 75% approval is required for the proposed parking conversion to be implemented
- i.e. If more than 25% of residents/property owners object, project cannot move forward
- Properties are weighted by Square Footage of Frontage so that a multi-family property cannot "outvote" a single family property with the same frontage on the street.
- Returns from Multifamily properties are weighted as a proportion of the number of residents and by that property's frontage
- All the proposed parking conversions on this agenda meet/exceed the approval threshhold as shown in Table A above.
