 - <u>Katherine.Fortner@mail.house.gov</u> Susan Davis attending and taken out of order. North Park generates the most communications to the office of any other community. Telephone town hall on February 28th. Payroll tax represents possible movement of congressional stalemate. Questions to the congresswoman on Nuclear Regulatory Commission, Medical Marijuana, Renewable Energy Production Tax Credit, Post Office Issues.
- 2) Lindsey Masukawa, Hon. Toni Atkins, State Assembly District 76, <u>Lindsey.Masukawa@asm.ca.gov</u> Introduced 3 bills AB 1522 which prohibits awards of spousal support, and inheritance rights to convicted abuse felons. Extends to same sex partners as well. AB 1588 assures professional licenses for active military deployments will not lapse. AB 1817 Requires computer technicians to report illegal sexual pictures to authorities.

Todd Gloria, Councilmember District 3 <u>ABernal@sandiego.gov</u> Historic preservation legislation amended to the municipal code that introduces fines for demolition of historic properties without permits. Urban agriculture muni-code amended to allow for specific agriculture practices. Jefferson Elementary School signed 20 year agreement for joint use park space 30 minutes before and after school. Councilmember Gloria holding a community coffee at Rebecca's from 10-12:00 Saturday February 26th.

- A. <u>AT&T Boundary St. (Public Right-of-Way, 4375 1/3 Boundary St., Project No. 226649</u>: CUP & SDP, Process 4, for a Wireless Communication Facility in the public right-of-way consisting of a 50'-0" high tower, 12 panel antennas, and an approximately 11'-9" by 25'-3" above ground vault for equipment. 4369 Boundary St & Meade Ave in the MR-800B <u>Motion</u>: To deny the proposed project based on: 1) nonconformance with current community plans, including Redevelopment Project Area and MAD plans, 2) conflict with existing community character, 3) inadequate vetting of alternate locations, and 4) environmental justice principles, i.e. the proliferation of radiation emitting wireless facilities within North Park residential communities. Granowitz/Barry 10-0-0
- B. C. Verizon Grace Baptist Church 3848 Georgia St. Project No. 237295, CUP for installation of a Wireless Communication Facility, Process 3, includes a 15'-tall tower extension to the existing church tower (current max height of 46'-5"). The tower to contain 12 antennas & 2 GPS antennas. Equipment located in an existing equipment room. MR-800B, process 3 CUP for non-residential use in a residential zone less than 100 feet from residential

property use. Motion: To approve the CUP as proposed in Design Option One (creating a white band around the top of the tower) Granowitz/Callen 10-0-0

- 3. **76 Gas Station (Circle K) A Development Permit and CUP** conversion of an existing service station facility to a Circle K convenience store with a Type 20 beer and wine license. The applicants are the

current owners, CN-1 Zone, mid-city PDO to convert 1,236 sf of service bays and add 399 sf to the existing 188 sf. convenience store, retaining 76 gasoline service, The police department has recommended approval of the license, The project's deviations include: closing one driveway on lowa and one on El Cajon; and expanding the retail store into the garage area (total size of footprint not larger than existing footprint). Motion: Approve CUP and SDP for 76/Circle K at 3154 El Cajon Blvd Granowitz/ Dye 7-1-0

- a. **Applicant** Planning on closing the entrances closest to El Cajon Blvd in order to reduce activity and increase parking as much as 10-18 total spaces. No additional pumps.
- b. **Martin Chevalier** requesting 6" curb on Boundary or barricade onto Boundary Street. Owners are amenable to fixing the curb and reducing impacts to Boundary Street
- c. Rob Steppke would like to add "and for the applicant to coordinate landscape design consistent with community entry criteria as determined by North Park Community Groups" owners are amenable to the landscape gateway changes. Agrees to work with the applicant.

MOTION Approve CUP and SDP for 76/Circle K at 3154 El Cajon Blvd with the applicant agreeing to coordinate landscape design consistent with community entry criteria as determined by North Park Community Groups as well as consider reduced impacts to Boundary Street including options to improve curb and potential traffic barriers. Moczydlowsky/Carlson 12-2-0 Morrison/Pyles voting no.

 - i. Significant issues for a CEQA review and determination that can result in an EIR revision and recirculation through the public review process are:
 - 1. Regarding stated Impacts & Mitigation for that impact.
 - 2. Do you agree with their conclusion(s)? If not, why not?
 - 3. Include comments on recommendation(s) to mitigate an unmitigatable item(s)
 - 4. Identifying impacts/environmental factors that were not identified
 - 5. Identifying impacts/environmental factors &/or mitigations that are insufficient or flawed.
 - 6. Identifying alternatives the applicant did not include, are incomplete or have been misrepresented.
 - a. EIRs are supposed to provide information to help establish the best solution to a problem. If viable options have not been included then there is no way to determine if the right alternative has been selected.

- b. Alternative recommendation must be viable.
- ii. Each NPPC comment needs a factual link from an adopted plan to go with the comment(s). Use Attachment 2 Existing City and Regional Planning Document, this attachment can be used as a crib sheet to assist you.
- iii. EIR Topic Areas for NPPC Members to Comment on Include:
