Robert Chavez of City of San Diego Redevelopment Agency introduced the presenters/developers Duncan Budlinger and Randy Levinson of The Shamrock Group. The site plans which were distributed were very preliminary and more definitive plans will be available for review at a later date. The 6th Implementation Agreement will help in purchasing the property. A motion was made by M. Cather and seconded by J. Wyman to support the 6th Implementation Agreement for Las Americas. - b. La Aldaba Senior Project: David Flores recused himself for discussion and vote on this project. Presentation of preliminary project proposal on the northwest corner of Averil Rd. and W. San Ysidro blvd. Presenting the project will be Susana Han of United Communities, developer of the housing project across the street, El Pedregal Family Apartments and Rick Montoya, project architect. The funding sources for this project will be through tax credits, Housing Commission and the Redevelopment Agency. United Communities will be the general partner and Casa Familiar will be the non profit partner. This project will be a mixed use project with 70 apartments (56 1-bedroom and 14 2-bedroom units) and approximately 8,200 sf of commercial retail. The ground floor will be commercial retail and parking and the other 2 floors will be senior housing. A motion was made by M. Freedman and seconded by A.
