Community Parks I Area Committee - Mr. Otsuji reported no meeting was held.
Community Parks II Area Committee - Representative not present
Balboa Park Committee - Director Field reported that a meeting was held in which the Fiscal Year 2021 Budget was presented, along with the Parks Master Plan using the same presentation given to the Park and Recreation Board in its last meeting.

Mission Trails Regional Park Citizens' Advisory Committee - Mr. Zosa reported no meeting was held.

## CHAIRPERSON'S REPORT

Vice-Chair Otsuji reported that the Parks Master Plan was heard at the meeting of the Planning Commission earlier that day and was approved unanimously.

Mr. Becker asked what the main comments the Planning Commissioners and members of the community had on the Parks Master Plan.

Vice-Chair Otsuji indicated there were comments made primarily about the Plan's new point system versus acreage.

Director Field indicated that he would send members of the Board a list of items contained in the report to the Planning Commission's requesting approval of the Plan.

## DIRECTOR'S REPORT

Director Field reported on the following:

- Reopening of the Balboa Park Central Mesa
- Reopening of beaches and bays, including Mission Bay Park
- City staff are currently working on a strategy to reopen recreation centers and youth camps
- A pending announcement regarding the reopening of pools would be made
- Looking to receive more guidance from the State and County regarding youth sports
- Have heard concerns about recreation groups and their ability to meet virtually and do plan on providing guidance in time for July meetings; Shelly Stowell is working on this effort
- Fiesta Island remains closed

Mr. Zosa asked about the reasons why Fiesta Island was open, but parking lots were closed. Director Field responded by saying that it was for public safety reasons and was an approach developed jointly between Parks and Recreation, Lifeguards, and the San Diego Police Department. Director Field also indicated that Fiesta Island (along with its parking lots) would open no later than July 6, 2020.

## 202. Rename the Skyline Hills Playground the "Robert Haynes Playground"

Presenters: Andrew Field, Department Director, Parks and Recreation Department Manuel Gonzalez, District Manager, Parks and Recreation Department

NOTE: No public comments were received for this item.
Director Field referenced comments made earlier in the meeting, acknowledging that the Park and Recreation Board Naming Policy 1001 was undergoing revisions and would be presented to the Board in the following months for review and discussion. He also indicated that the reason why this item was being heard at today's meeting was the following: the person in question and there has been no opposition from anyone in the community. Much of the issues raised with renaming efforts underway involve living persons. Another reason why the item was being heard was because the construction of the Skyline Hills Community Park is to be completed soon and the renaming of the playground would be timely.

Discussion between Board members and City staff occurred primarily regarding the public input and outreach efforts done to bring the proposed renaming forward. In addition, new requirements for the revised Naming Policy were discussed. Director Field indicated that all proposed renaming efforts would be on hold until the Naming Policy was updated. The renaming for the Skyline Hills Playground will be in the form of an aluminum sign.

A motion was made by Mr. Anastasopoulos and seconded by Mr. Baron to rename the Skyline Hills Playground to the "Robert Haynes Playground" with these conditions:

The updated Park and Recreation Board Naming Policy 1001 include requirements for the following:

1. The impacted City Council member be made aware of the renaming effort underway.
2. Obtain letters of endorsement from three community organizations.
